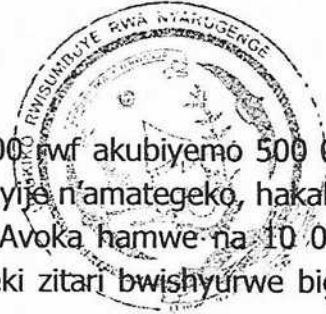

Na ho kuba SORAS ivuga ko igihembo cya huissier ari 40 000 rwf kuko ari inshuro 2 zo kumenyesha urubanza gusa zakozwe kandi signification 1 ikaba ari 20 000 rwf, uru rukiko rusanga Atari ko bikwiye kumvikana kuko signification (kumenyesha urubanza) biri mu mihango inyuranye twavuze ko iyo yatangiye gukorwa bigaragaza ko hatangiye irangizarubanza ku gahato, kandi uru rukiko rukaba rutabona uburyo ki irangizarubanza rigizwe n'urukurikirane rw'imihango inyuranye, habaho kuribaramo ibice.
